



ANNEXATION ORDINANCE

An Ordinance annexing territory in Section 5, Town 2 North, Range 11 East, Town of Plymouth, Rock County, Wisconsin.

WHEREAS, the Village of Footville has recently acquired ownership of property contiguous to the corporate boundaries of the Village; and

WHEREAS, the Notice requirements of Wis. Stat. § 66.021 do not apply to annexation of owned territory undertaken pursuant to Wis. Stat. § 66.025; and

WHEREAS, the Board of Trustees of the Village of Footville has determined that the annexation is in the public interest;

NOW, THEREFORE, the Board of Trustees of the Village of Footville do ordain as follows:


Section 1. The territory described as follows is hereby annexed to the Village of Footville:

PART OF THE N.E. 1/4 OF THE S.E. 1/4 OF SECTION 5, T. 2 N., R. 11 E. OF THE 4TH P.M., PLYMOUTH TOWNSHIP, ROCK COUNTY, WISCONSIN DESCRIBED AS FOLLOWS:

Beginning at a point on the East line of the S.E. 1/4 of Section 5, aforesaid, 395.00 feet South 2°30'00" East of the East 1/4 corner of said Section; thence continuing South 2°30'00" East along said line 195.21 feet to the Northerly right-of-way line of S.T.H. '11'; thence South 32°28'22" West along said line 140.52 feet to Meander Corner No. 1; thence continuing South 32°28'22" West 20.0 feet more or less to the centerline of Bass Creek; thence Northwesterly and upstream 527.6 feet more or less; thence North 2°30'00" West 27.5 feet more or less to Meander corner No. 3, said Meander Corner No. 3 being located from Meander Corner No. 1 as follows; beginning at Meander Corner No. 1; thence North 68°09'54" West 158.53 feet to Meander Corner No. 2; thence North 59°23'16" West 388.02 feet to Meander Corner No. 3; thence North 2°30'00" West 448.81 feet to the East-West centerline of Section 5; thence North 89°39'36" East along said line 517.37 feet; thence South 2°30'00" East 151.24 feet; thence South 87°30'00" West 67.00 feet; thence South 2°30'00" East 245.00 feet; thence North 87°30'00" East 100.00 feet to the place of beginning. Containing 7.1 acres more or less. **Population is zero.**

Section 2. A plat of the territory annexed to the Village of Footville is attached hereto and made a part of this Ordinance.

Section 3. After the annexation becomes effective, the above-described property shall be exempt from further taxation and assessments in the Town of Plymouth, and henceforth shall be subject to taxation and assessments as a part of the Village of Footville for any and all purposes provided by law.



Section 4. This Ordinance will take effect upon passage and publication as provided by law.
